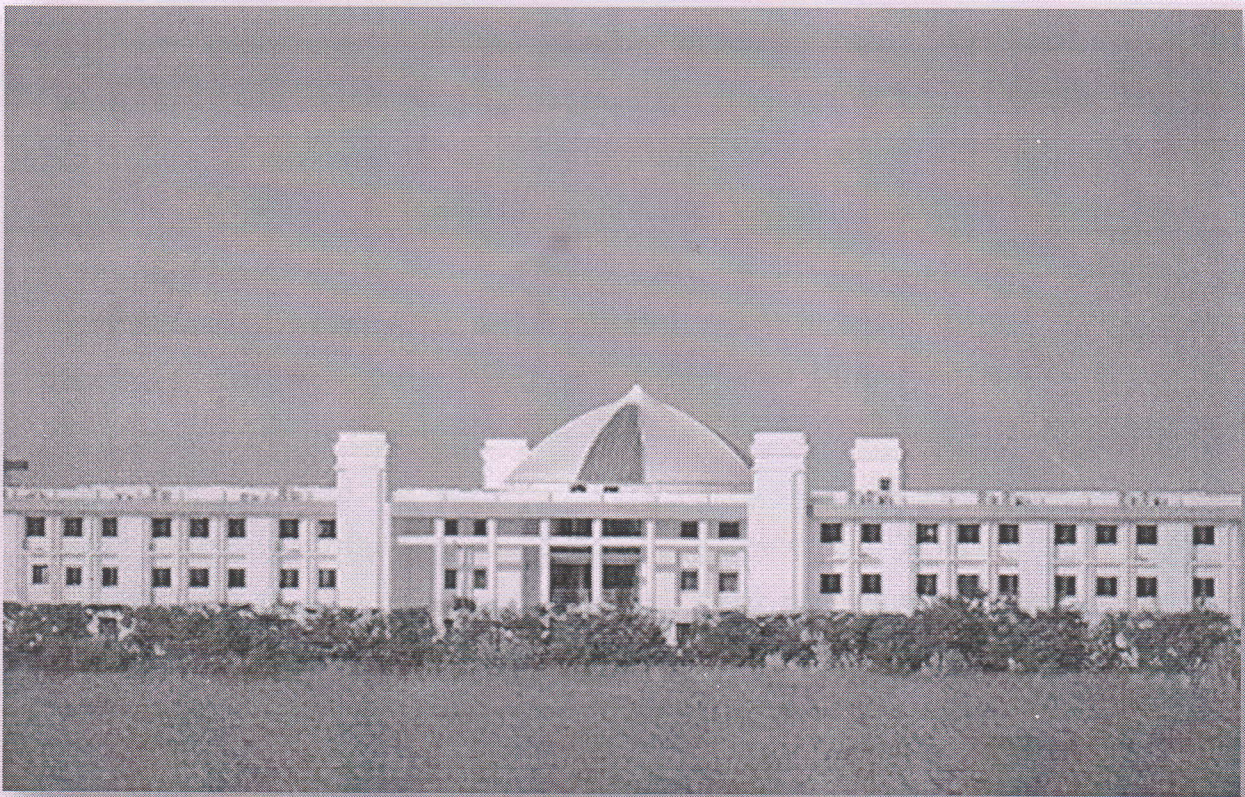



Aim of the Seed Money Policy

Seed Money Policy (SMP), sponsored by Invertis University, Bareilly, UP, aims to promote research and innovation among all faculty members of the university. Seed funding under this policy is to initiate/continue the research work in native research areas along with inter-disciplinary research areas. This policy aims to promote research work among the faculties and encourage innovation in projects at the university and industry levels. The applicant has to justify that the proposed project represents a new research direction in an area likely to generate a fruitful outcome. The research project that is already supported by other sources will not be considered for funding.

Objectives of the Policy

The Objectives of the Policy are:

- To provide seed money for initiating/continuing the research work by faculty members of the university.
- To encourage as well as motivate more researchers to conduct preliminary research and support their novel ideas for imparting confidence in research directions

Nature and Duration of Support

The Seed Money will be a one-time allotment for a year/ project. It shall be as per the need of the project for the procurement of consumables, equipment, software, etc.

Terms of Reference and Guidelines:

- The applicant should be associated with Invertis University in the respective department of their research area

- Proposals for Seed Money Allotment are invited based on the "CALLS" released by the Office of Dean-Research & Development (two to four times a year) across all the Institutes.
- Faculty members can submit their proposals as per the template **(Annexure 1)** with approval from their Heads of the Department and respective Deans.
- The Principal Investigator (PI) must have a Ph.D. degree.
- If a proposal is turned down by the Research Advisory Committee, the PI is allowed to submit a new proposal in the same year.
- The Seed Money Policy (SMP) will be discontinued in the absence of PI for more than 30 days of unsanctioned leave and in such case, PI will have to return the money. If the leave is taken due to unforeseen health conditions, then PI may get special permission to continue the SMP.
- In case of resignation without completion of SMP, PI has to refund all the money availed under the policy to Invertis University.
- In case of maternity leave, PI will be given special permission to extend their project after joining duty. However, prior permission is required in such cases.
- After completion, the PI must submit a proper report along with achievements, and deliver a formal presentation in the respective department before the committee.
- The Vice-Chancellor shall nominate the Members for the Expert Committee to review proposals related to Seed Money Allotment.
- The Research Advisory Committee (RAC) will evaluate the submitted proposal for feasibility and proposed outcomes. Based on satisfactory input from the PI, the research proposal will be recommended for seed funding under SMP.
- After recommendations from the Expert Committee, the final approval is granted by the Vice-Chancellor.
- The policy implementation for Seed Money Allotment shall be routed through the appropriate administrative chain, namely:

- Heads of Department shall initiate along with Principal Investigator
 - Dean shall forward to the Office of Dean-Research & Development
 - The Expert Committee shall review and recommend the Proposal
 - The Vice-Chancellor approves and sanctions Seed Money Allotment to the Principal Investigator.
- A sanction letter shall be issued to the PI from the Office of the Dean-Research & Development.
- The decision by the Dean-Research & Development is deemed final.
- After the receipt of the sanction letter, the Investigating Team may request for advance/initiate procurement as per the general practices adopted in the University.
- All expenses related to Seed Money Allotment shall be maintained in a separate file by the investigating team and submitted the same to the accounts department as and when required.
- All payments inclusive of GST about Seed Money Allotment shall be in favor of "Invertis University" payable at Bareilly and payments shall be credited to the vendors/suppliers as per the issued PO as well as other terms and conditions.
- The university shall ensure compliance with statutory laws and taxes.
- All invoices/quotes should be in the name of the university along with the GST Number.
- It is the responsibility of the investigating team to provide all bills duly certified for the expenditure incurred for the project to the accounts team promptly.
- Equipment and resources can be utilized with prior approval from the Dean and Head of the Department of the respective Institute.
- The investigating team may engage the services of university amenities by paying the expenses accordingly.

Seed Money Allotment Guidelines:

- The amount of seed money requested by the PI can be sanctioned in the following manner: Publications (40%), PI Experience (20%), and Equipment and Services (40%).
- **Expected Outcomes (40%)**
 - Publications in any of the renowned journals (SCI/Web of Science/ Scopus)
 - Minimum 4 publications in the proposed area of research are necessary.
 - An amount of ₹ 20,000 can be sanctioned for each publication.
 - For a granted patent ₹ 30,000 can be sanctioned.
 - For a published patent ₹ 25,000 can be sanctioned.
 - DST Proposals
 - Prototypes
 - Any other outcome
- **PI Experience (20%)**
 - PI must have experience in the proposed research field.
- **Equipment/Services (40%)**

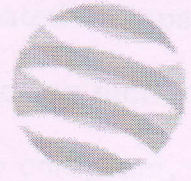
Achievements:

The key achievements include:

- Instigation of pioneer research on thrust areas affecting global scenarios to improve the research profile of the university
- Devising research groups for the academic growth of faculty members, PDFs, doctoral scholars, and PG students
