

GENERAL

In this document, CorporateServe Solutions Pvt. Ltd. is abbreviated as CorporateServe and Invertis University, Bareilly as INVERTIS or Customer. Purpose of Annual Maintenance Support (AMS) contract is to provide services for helping Invertis University in maintaining and further enhancing ERP software. Since implementation of ERP was recently completed by CorporateServe, now ERP is required to be properly maintained and further enhanced.

SCOPE

This is primarily a shared offshore support/enhancement model. It means primarily the support will be provided by shared team of Corporate Serve, resources from remote office of Corporate Serve for delivered solution as per <u>below scope</u>:

- Errors or changes or rectifications in transactions in any modules / functions / activities of Microsoft Dynamics NAV 2016 as already implemented including student and faculty and staff portals.
- 2. Fixing/Escalating any errors in the already implemented solution only.
- Reporting on base product bugs to Microsoft & following up for solutions.
- 4. Any new developments i.e., reports or customisations.
- Information sharing about latest patches, notes, enhancement packs. Implementing minor
 patches or notes that are mandatorily required by Government of India. Implementing major
 patches or notes are out of scope.
- 6. Any other services on ERP as may be mutually agreed from time to time.

It is assumed that INVERTIS will have its own IT coordinator who shall coordinate with the users and shall take care of the day to day administration, maintenance of the hardware, networking, server, database, user access rights, back-ups, passwords, and user related issues of ERP. CorporateServe shall nominate one coordinator for the INVERTIS to coordinate. Back end support from rest of the team of CorporateServe will be taken by this coordinator.
