Subject: **Compliance submitted by the University in respect of the observations/ suggestions given by the UGC's inspection Committee.**

Sir,

This has reference to the visit of the UGC/AICTE inspection Committee to the University during **21-22nd September, 2015** and subsequent compliance submitted by the University in respect of the observations/suggestions given by the UGC/AICTE inspection Committee. The report of the above Committees along with the compliance submitted by the University was placed before Committee of UGC members for consideration. The Committee recommended as under:-

The Committee considered the report of the UGC's inspection Committee, AICTE Expert Committee, advice of AICTE along with the compliance report submitted by the University in respect of the observations/ suggestions given by the above Committees.

The Committee observed that the number of regular faculty in the University is still not as per requirements of the AICTE/UGC norms.

The University is, therefore, required to recruit required faculty as per AICTE/UGC norms.

The University should submit department-wise details of the intake capacity, students actually admitted, faculty sanctioned, faculty required as per the norms of UGC/AICTE and faculty actually available. The University should also submit department-wise list of the faculty actually available with qualification, experience, pay scale, date of joining, whether permanent/guest faculty/ visiting faculty, etc. for consideration of the Committee. Documents related to the appointment of faculty after the UGC visit also to be submitted.

The above recommendations of the Committee along with the Report of the UGC inspection Committee were placed before the Commission in its 529th {Item No. 1.02(a)(ii)} held on 08.02.2018. The Commission approved the recommendations of the Committee.

STATEMENT OF OBJECTS AND REASONS

With a view to encouraging private sector to participate in the field of higher education, it has been decided to establish and incorporate a teaching University by the name of Invertis University, at Bareilly in Uttar Pradesh sponsored by Uttaranchal Welfare Society, Ghaziabad Registered under the Society Registration Act, 1860 (Central Act No. 21 of 1860), so as to provide to the students and teachers the necessary atmosphere and facilities for the promotion of innovations leading to proper structuring of courses, new methods of teaching and learning and integral development of personality.

The Invertis University Uttar Pradesh Bill, 2009 is introduced accordingly.

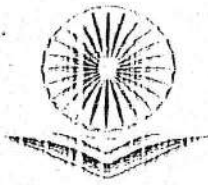

Sir,

With reference to State Government Notification No.1105(2)/LXXIX-V-1-10-1 (Ka)29-2009, dated 1st September, 2010 on the above subject. I am directed to say that Invertis University, Bareilly (Uttar Pradesh) has been established by an Act (No. 22 of 2010) of State Legislature of Uttar Pradesh as a State Private University and is empowered to award degrees as specified by the UGC under section 22 of the UGC Act 1956 through its main campus with the approval of statutory bodies / councils, wherever required.


As per the judgment of the Hon'ble Supreme Court in the case of Prof. Yashpal Vs State of Chhattisgarh, there is no provision to have Regional Centres / off Campus beyond the territorial jurisdiction of the State.


Keeping in view of the above, you are requested to ensure on the following:-

1. No off campus centre(s) is opened by your University outside the territorial jurisdiction of the State in view of the judgement of Hon'ble Supreme Court of India in case of Prof. Yash Pal Vs State of Chhattisgarh.
2. In case the University has already started any off campus centre outside the State, it must be closed immediately. It may also be ensured that any off campus centre within the State shall be opened only as per the provision laid down in the UGC (Establishment of and maintenance of standards in Private University) Regulation 2003 and with the prior approval of UGC.
3. The University shall not have any affiliated Colleges.
4. The University has to follow UGC Minimum standards and procedure for award of M.Phil / Ph.D degree) Regulations, 2009.

The University is required to follow the UGC (Establishment of and Maintenance of Standards in Private University) Regulation, 2003 (copy enclosed) & other Regulations issued from time to time and posted on UGC website www.ugc.ac.in.




